Ordinance No. 20 AN ORDINANCE REGULATING AND LICENSING RESTAURANTS, REQUIRING THE PHYSICAL EXAMINATION OF FOOD HANDLERS AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF. The village council of Shelly do ordain as follows: Sec. 1. Unsanitary Conditions Prohibited. No person shall operate any restaurant, cafe, dining room, or eating house, if the same is in a filthy, unclean or unsanitary condition. Sec. 2. Power of the Board of Health. If, in the opinion of the board of health, after an investigation thereof, any restaurant, cafe, dining room, or eating house is operated in violation of Section 1 of this ordinance, the board of health shall notify

in writing the proprietor or proprietors, owner, or owners, manager or managers of such restaurant, cafe, dining room, or eating house to place the same in a clean and sanitary condition within reasonable time to be stated in said notice, which time so stated shall in no case be less than two days, and failure to comply with such notice within the time so stated shall be deemed a violation of the provisions of this ordinance. a violation of the provisions of this ordinance.

Sec. 3. Diseased Employees Prohibited. It shall be unlawful for any person to work in or about any restaurant, cafe, dining room, or eating house, or allow any person or persons to work in any such place whose condition is such that disease may be spread to his associates direct, or through the medium of food or food products, likely to be eaten without being cooked after handling, whether such condition be due to a contagious, infectious, or venereal disease, in its active or convalescent stages, or to the presence of disease germs, whether accompanied by, or without any symptoms of the disease itself.

lawful for any person to engage in the handling and sale of food or food products in any restaurant, cafe, dining room, or eating house without having secured from the village health officer a certificate of good health annually on or before the first day of January, or at the time of beginning work. The health officer may charge the person examined a fee of two dollars (\$2.00) for the examination of each person and the issuance of the certificate.

sec. 5. Special Physical Examinations. Whenever a complaint is made, or whenever in the opinion of the board of health the same is necessary, special physical examinations of persons suspected of violating Section 3 hereof shall be held, and such persons may be prohibited from continuing such employment if they are found to be discorded on otherwise to be received the provisions of to be diseased or otherwise to be violating the provisions of such section.

Sec. 6. License Required. Every person who owns or operates any place of business enumerated in Section 1 hereof shall procure annually on the first day of January, or at the time of commencing such business, a license from the village recorder, for which they shall pay \$5.00 each year.

7. Penalty. Any person who violates any provision of this ordinance shall upon conviction thereof be deemed guilty of a misdemeanor.
