

ORDINANCE NO. 41

AN ORDINANCE ESTABLISHING MINIMUM WATER RATES AND CERTAIN REGULATIONS PERTENANT THERETO.

The Village Council of the Village of Shelly, Minnesota, Dees Ordain As Follows:

Section 1. Charges for Water Service. The minimum charge for water service shall be \$2.50 per month, which minimum charge shall cover the first 2000 gallons used per month. The user shall pay Fifty (50¢) Cents per 1000 gallens on the next 10,000 gallons used in the month. On the next 10,000 gallons the user shall pay at the rate of Forty (40¢) Cents per 1000 gallons used in a month. On the next 10,000 gallons the user shall pay at the rate of Thirty (30¢) Cents per 1000 gallons used in a month. On all water in excess of 32000 gallons in a month, the user shall pay at the rate of Twenty (20¢) Cents per ~~gallons~~ 1000 gallons. Any fractional part of 1000 gallons shall be deemed to be 1000 gallons for the purpose of the rates set out herein.

Section 2. Rules and Regulations Governing Water Service.

Subd. 1 To obtain service the applicant must apply at the office of the Village Clerk or Water Superintendant.

Subd. 2 Notice to discontinue service must be given by the customer at the office of the Village Clerk or Water Superintendant, or the Village may continue the service and charge for service until such notice is received.

Subd. 3 Customers are strictly forbidden to interfere or tamper with meters, and the Water Department reserves the right in case of such violation to discontinue service without notice and remove its property from the premises.

Subd. 4 The customer will be charged \$ 1.00 for reconnection of any service after being discontinued for any cause.

Section 3. The Village Water Department reserves the right --

Subd. 1 To require a deposit from a customer to secure the payment of any bills as they mature. Deposits will be returned to the customer upon discontinuance of service and payment of all accounts due the Department. Amount of deposit shall be determined by the Council and/or the Water Department.

Subd. 2 To require, before making new service connections or extensions of systems, such a guarantee of sufficient revenue from them as will insure reasonable profit upon the investment of such connections and extensions. Service to property outside the Village's corporate limits but adjacent to the Village may be served subject to the foregoing considerations.

SECTION 21. PENALTY: Any person violating the provisions of this act shall be guilty of a misdemeanor and upon conviction thereof shall be fined not more than \$100, and in default of payment of such fine shall be imprisoned until such fine is paid, not exceeding ninety days.
