Proceedings of the City Counci Shelly, Minnesota April 03, 2023



The City Council met 03 Apr 2023 at the Shelly City Hall. Assistant Mayor George Swenson presided. Council members present were Gene Dybing, Tom Keeney Jr., and Todd Swalstad. Also, present was David Swenson, Jonithan Meyer, Wayne DeYoung, and Mark Dohman. Mayor Ron Cakebread was not in attendance.

The council meeting was called to order at 07:00 P.M.

Assistant Mayor George Swenson opened the meeting.

A Motion was made by Dybing and seconded by Keeney to accept the minutes of March 06, 2023, city council meeting. Motion carried

The council discussed the Rural Water project and email request from AE2S.

The council discussed McGuire Iron.

Delinquent bills were reviewed and discussed.

A Motion was made by Swalstad and seconded by Keeney to pay the bills, all excepted Railroad Management, and Maguire Iron Inc. Motion carried

A Motion was made by Dybing and seconded by Swalstad to approve the liability coverage waiver: As the city does not waive the monetary limits on municipal tort liability established by Minn stat 466.04. Motion carried

A Motion was made by Keeney and seconded by Swalstad to approve Petals on Main to plant flowers in the city's welcome sign flower bed and the city's flowerpots. Motion carried

The council approved buying (2) generators, (4) two-way radios, (2) work lights, (6) 100-foot extension cord, cases of water, (6) 3 outlet extension cords.

Dohman's report stated: Total power delivered to the city for Feb was 244,000 kwh. Audit package submitted. Spring clean-up is May 23, 2023, and brush pick-up is June 06, 2023. Red lake Falls Veterinarian Clinic is at the Nielsville firehall 5:00-7:00pm on 31st of May 2023. Shelly's 2022 Drinking water compliance report is in.

Jonithan's report stated: The monthly water usage for March was a total of 392,600 gallons with a daily average of 12,664 gallons per day.

The monthly wastewater that was pumped out to the ponds was 356,000 gallons with a daily average of 11,000 gallons per day.

The monthly peak of 454KW occurred on the 2nd of March 2023 at 8:30pm.

Jonithan also reported for March: Liftstation Samples taken on the 20th of March. Ran all four portable water pumps. Replaced battery in the pickup. Went through the Liftstation generator. Snowblowed out the East side of town and through the windbreak up to Highway 75 ditch, Then North on Highway 75 ditch to first crossing, and staging area for 6-inch pump by west side of the dike drain.

A Motion was made by swalstad and seconded by Keeney to adjourn at 8:15 P.M. Motion carried.
