

ORDINANCE NO. 20

AN ORDINANCE AMENDING ORDINANCE NO. 36, BEING AN ORDINANCE REGULATING THE USE OF STREETS AND HIGHWAYS WITHIN THE VILLAGE OF SHELLY, MINNESOTA, AND IMPOSING PENALTIES FOR THE VIOLATION THEREOF.

The council of the Village of Shelly, Minnesota, do ordain as follows:

Section 1. Subdivision 2. of Section 2. of Ordinance No. 36 is hereby amended to read as follows:

Subdivision 2. No vehicle shall be driven thereon at a speed in excess of 30 miles per hour on any highway or street on which a different speed has not been established by the commissioner of highways under M.S.A., Section 169.14. On any street where a different speed zone has been so established and signs have been posted calling attention to such zone, no vehicles shall be driven in the village at a speed greater than that indicated on such signs.

Section 2. Section 9. of Ordinance No. 36 is hereby amended to read as follows:

Section 9. DRIVING UNDER THE INFLUENCE OF LIQUOR OR NARCOTICS AND HAVING OPEN BOTTLE:

Subdivision 1. Driving Under the Influence of Liquor or Narcotics: No person who is an habitual user of narcotic drugs or who is under the influence of narcotics or liquors shall drive or operate a vehicle within the Village, and no person shall consume liquor while an occupant of a vehicle upon any street in the Village.

Subdivision 2. Open Bottle:

(a) No person shall drink or consume intoxicating liquors or non-intoxicating malt liquors in any motor vehicle when such vehicle is upon a public highway or street in the village.

(b) No person shall have in his possession on his person while in a private motor vehicle upon a public highway or street in the village, any bottle or receptacle containing intoxicating liquor or non-intoxicating malt liquor which has been opened, or


