

The City Council met 06 Feb 2023 at the Shelly City Hall. Mayor Ron Cakebread presided. Council members present were George Swenson, Gene Dybing, Tom Keeney Jr. and Todd Swalstad. Also, present was, Jonithan Meyer, Wayne DeYoung, and Mark Dohman.

The council meeting was called to order at 07:00 P.M.

Mayor Ron Cakebread opened the meeting.

A Motion was made by Swenson and seconded by Swalstad to accept the minutes of January 09, 2023 city council meeting. Motion carried

Delinquent bills were reviewed and discussed.

Dohman's report stated: Total power delivered to the city for Dec was 271,471 kwh. Working with a web site designer creating the city's website. Submitted the following reports: PERA leave report, PERA exclusion report, State indebtedness report, Unemployment report, State withholding, State budget report, State political report, Power generation report and Federal 941. City shop cameras stop working. The city's power interrupters no longer work with 3g being shutdown Jan 2023. Fire dept relief supplement benefit reimbursement has been submitted. Working on MN Public Facilities Authority Compliance. May 23, 2023 is the spring clean-up.

Jonithan's report stated: The monthly water usage for January was a total of 374,100 gallons with a daily average of 12,067 gallons per day.

The monthly wastewater that was pumped out to the ponds was 355,000 gallons with a daily average of 11,450 gallons per day.

The monthly peak of 484KW occurred on the 30th at 5:30am.
